ePACT and Vermont Systems Inc. to Launch System Integration in 2019

Vancouver, British Columbia - ePACT Network and Vermont Systems Inc. (VSI) announced their strategic partnership in April 2018, to better support community-focused organizations, and the families they serve, across North America. As the next step in the partnership, VSI will begin development on the integration of its system, RecTrac 3.1, with ePACT, to aid clients collecting specialized emergency and health data from program participants. Integration is slated to launch in Q1 of 2019.

Connecting RecTrac and ePACT through an API (Application Program Interface) will create a streamlined experience for families as they register for programs. They will receive their ePACT invitation shortly after registering, making the collection of critical information much faster. In addition to automated invitations, clients can also use <u>automated reconfirmations</u> to easily remind families who have yet to submit their ePACT record - both features are designed to support the API integration and help staff keep participant information up-to-date.

This will better connect ePACT with the RecTrac registration process, making the experience seamless, and helping recreation organizations efficiently collect critical information from families."

ePACT Network supports RecTrac clients with HIPAA-compliance through a number of features:

- **Authorized administrators:** Access to participant information is controlled at the client-level to ensure participant privacy is protected.
- Audit records: Clients can see who accesses participant information when necessary.
- **Full encryption:** ePACT uses the same high level of encryption as online financial institutions to protect family data.

"We know that ensuring the safety of participants is a top priority for recreation organizations everywhere, and by providing a connected experience between RecTrac and ePACT, we can help reduce time spent managing critical information for the families they serve,' says Kirsten Koppang Telford, COO of ePACT. "We're thrilled to move our partnership with VSI forward, and provide a way to maintain data integrity, completeness, and accuracy across registration and information management processes."
